



PRESIDENT'S REPORT



Sisters and Brothers,

2021 has been a very challenging year for our members from the many months of layoffs due to the conductor chip shortage created by the pandemic to the elimination of another shift back in July. 2022 is looking to be another challenging year for us as we wait to hear about potential future product. Many of our members at our outside supplier Units have had no choice but to find work elsewhere because of exhausting their unemployment benefits and running out of their insurance benefits. We have lost many members from Stellantis due to transferring to other Stellantis locations just to keep their Company paid benefits going and many more of those members have had to turn down those transfer opportunities and lose their Company paid benefits because they couldn't just pack up and leave their families.

Your local leadership recently met with the President and CEO of United Way for the Rock River Valley asking what resources are out there to help our members through this very difficult time. We will be sharing that information in this Union Voice and also on our local website (uaw1268.org). We encourage all of our members that are indefinitely laid off or have been laid off and out of unemployment benefits with no SUB pay and struggling to make ends meet to use this information to take advantage of these services.

We will also be having another job fair at Local 1268 sometime in January to have local employers come out and talk about their business and hiring opportunities. We will be talking with The Workforce Connection to get the job fair put together with employers and we are requesting Companies only that are offering their starting wages at least \$17 per hour or more.

This is a very difficult time for everyone and I pray that we get some good news in the near future about new product so we can start to get people back to work and able to provide for their families. I hope this finds everyone in good health, and despite the challenging times, I'm hopeful this holiday season can bring some joy to you and your family.



Utility Bills

LIHEAP, Low Income Home Energy Assistance Program, provides energy assistance for residents in which a benefit is paid directly to the utility companies on behalf of income-eligible households. If eligible, you might get help with your ComEd, NICOR and Water & Sewer bills. Contact United Way of Boone County, (815) 544-3144, to schedule LIHEAP appointments for Boone County residents.

Emergency assistance for food, shelter, utilities, and medicine.

The **Belvidere and Boone County Salvation Army** provides emergency financial assistance. There may be resources for food, shelter, utility and heating bills, and prescription medicine. Or children can get free school uniforms or supplies, winter jackets or clothes, or Christmas gifts. They can also refer people to various local charities and non-profit agencies as well as transitional housing programs in Boone County. Phone 815-544-3892 for information.

Free legal aid in Boone County Illinois

Prairie State Legal Services is a non-profit law firm that provides low income, elderly and others with free legal advice, information on how to get legal aid, and free legal representation to people in need of help. Call 815-965-2902 to learn more.

Wear masks, distance when able, wash your hands frequently, and always stay home if you are sick. Financial Secretary Report

Greetings Sisters and Brothers;

The last 2 years have been very trying times. I believe in the resolve of this membership to stay dutiful

And continue to put their best work effort forward as we continue to ride out these difficult times. I know you have all heard this before, but it is the truth. The automotive industry is very cyclical. When business is booming, bank as much as you can. We are definitely in a down loop right now. History says that we will eventually pull out of it and get back to some semblance of normalcy.

As I have already received numerous calls, I will try to use this space to explain what will happen in January. As of this writing, FCA/Stellantis has announced the first 2 weeks in January to be down weeks for production. If you have IDES benefits left, you will file for unemployment as usual the week of January 3-7. If you are among the vast majority of employees currently out of benefits and your benefit year resets on 01/11/2022, you will be able to file during the second week of January (January 10-14). If you are not sure you do or don't have benefits, I would recommend trying to file the first week of January. If you have exhausted your benefits, it will not let you file a claim rather you will get a message saying that your benefits are exhausted and you can't file at that time.

To FCA/Stellantis workers asking about SUB. SUB (supplemental Unemployment Benefit) is by its very name a benefit and is therefore handled by your Benefit Reps. They will be putting out information specific to SUB, I will just touch on some commonly asked questions. Most of you have already uploaded your "Benefit Payment Explanation" sheet to the HUB to receive SUB earlier this year. Therefore, in order to get paid for the first week of January, you will have to manually enter for the SUB on your HUB account. Remember that you can't put in for SUB until the following week (Monday January 10th at the earliest). For the second week, it is extremely important that you remember to file your IDES claim in that week. You will then receive a UI finding sheet where your date of claim will match your benefit year begin date. This signifies that it is your waiting week, and that sheet will have to be uploaded in order to get paid for the second week. I can't stress how extremely important it is that you certify for that week, 2 weeks after you file. If you file and don't certify to get credit for your waiting week, you will lose that amount of money the next time you file, which will likely happen early next year. IDES does NOT backdate claims. They view it that you have one job on the week you are laid off and not working, and that is to file a claim. If you have not registered with the new IDES system yet, DO IT NOW!!! Almost a quarter of everyone I assisted had to contact IDES for assistance in getting through the registration for the new security system. Don't wait until January if you haven't done it yet.

I want to wish you all a very safe and happy holiday season! The hall will be closed as of 12/24/2021 and will re-open on 01/03/2022. Assuming that we go back to traditional 40-hour work week, the hall hours will go back to 8 am-4 pm; Monday –Friday come January. There is reason to be hopeful for next year. Let's finish this year as best we can and look forward to getting back to consistent running.

All UAW local unions must have standing committees to make a lasting union and community impact. Whether you’re interested in veterans, politics, community work, civil rights, education, recreation, or something else, you can fire up your local union by volunteering to serve on a committee or helping with a committee project as your time permits.

HOW DO I JOIN?

Just stop down at the Union Hall and request a committee application. Hall hours are 8:00 am to 4:00 pm, Monday thru Friday.

- You may join up to two Standing Committees.
- You may join the Chaplaincy Program or any sub-committees. (even if you are on two standing committees)
- The Election Committee is elected at the September General Membership Meeting immediately preceding the General Elections. (Next election of committee will be in September, 2022. Watch your union boards for notification of election)



UAW LOCAL 1268 COMMITTEES

Standing Committees:

CONSTITUTION AND BYLAWS COMMITTEE: Monitors and maintains our Local Union Bylaws, making sure existing bylaws conform to our International Constitution. Researches and acts upon any new bylaws that are submitted.

CONSERVATION-RECREATION COMMITTEE: Works to promote meaningful recreation and leisure time activities, and also develops to help correct energy and environmental problems.

CIVIL AND HUMAN RIGHTS COMMITTEE: Serves as Guardian over the Local Union's interest to assure the members full rights regardless of religion, race, creed, color, sex, political affiliation, national origin, age, or handicap. Informs members of steps and procedure, including filing of complaints whenever a member or members believe their rights have been violated, either by management or by other Union members in the workplace, in the community, and the nation. (This committee should mirror the diverse population of our workforce).

COMMUNITY SERVICES COMMITTEE: Works through public and private organizations to assure that problems faced by our members in emergency situations get the help they need. Generally, handles the strike insurance benefits when local Unions are force to use their economic strength.

CITIZENSHIP-LEGISLATION COMMITTEE: Also known as Community Action Program (CAP). The in-plant political arm of the Local Union and is the basic link to our members concerning legislative issues and elections that affect us as workers and trade Union families.

EDUCATION COMMITTEE: Works with all other committees and the leadership to inform our members on issues and mobilize greater solidarity behind the program of our Union.

UNION LABEL COMMITTEE: Emphasizes the importance of supporting those goods produced in Union shops, by members under union-won working conditions. Also alerts members of manufacturing that has been moved out of the United States and product boycotts endorsed by the AFL-CIO.

VETERAN'S COMMITTEE: Seeks members who are willing to represent the interest of all active and retired UAW Veterans and their families. This committee is dedicated to advocating for the political and social concerns of Veterans.

WOMEN'S COMMITTEE: Promotes greater understanding of the UAW's policies and programs. Furthering the objectives of our Union in the communities in which we live. Conducts programs which are of special interest to women. Encourages women to become active in our Union.

Sub-Committees:

PARANORMAL: Sub-committee of the Veterans Committee that explores the existence of the unknown.

MOTORCYCLE: Sub-committee of the Veterans Committee that are dedicated to raising motorcycle safety awareness for both riders and non-riders for fun & safe motorcycle riding, along with supporting local charities.

SPORTSMENS: Sub-committee of the Recreation Committee that promotes through education the importance of good sportsmanship and the conservation of wildlife and other nature resources.

WORKERS WITH PRIDE: Sub-committee of the Civil & Human Rights Committee that works to ensure equality for LGBT families by building community awareness and advancing social justice for all families.

UAW Programs:

CHAPLAINCY: It shall be the duty of each member/chaplain to render aid and assistance to a brother or sister in cases of illness, death or distress, and in every way acquit her/himself as a loyal and devoted member of the International Union.

UAW PRESIDENT RAY CURRY PARTICIPATES IN SEMICONDUCTOR CHIP SHORTAGE ROUNDTABLE



Today, UAW President Ray Curry joined a roundtable hosted by Congresswoman Debbie Dingell (MI-12) and U.S. Secretary of Commerce Gina Raimondo at UAW Region 1A in Taylor, MI to discuss the nation-wide semi-conductor shortage and its impact on autoworkers across the state and country. Michigan's Governor Gretchen Whitmer, the state's Senators and Democratic members of Congress, as well as representatives from Ford, GM, and Stellantis were also in attendance.

Currently, the United States only produces about 14% of the global semi-conductor stock, and shortages are holding back the production of vehicles as well as work to transition to building more electric vehicles. Participants in the roundtable all encouraged the passage of the U.S. Innovation and Competition Act in both the House and Senate, which includes \$52 billion for domestic semiconductor production.

"This is both a challenge and an opportunity," said UAW President Ray Curry, "We have an opportunity to work with Congress and the Biden Administration to develop trade and policy solutions that ensure that advanced technology that has been offshored is brought back and new technology stays right here in the United States produced by UAW workers."

The UAW looks forward to continuing to work with our partners in Congress and the Biden Administration to increase semi-conductor production here in the United States.



You will be surprised of how interesting all of this will be for you, especially learning of our own training center in our own back yard, located in Ottawa, Illinois known as the “Pat Greathouse Center” which is named after one of our great leaders of Region 4, who also worked with our fourth UAW President, Walter Reuther, as Vice-President. He was a union member of Local 551 (Ford Stamping Plant) located in Chicago Heights. We are fortunate to be the only Region with our own Education facility.

The Walter and May Reuther training facility, otherwise known as “Black Lake” located in Onaway, Michigan, is where the majority of our UAW members go for training and International conferences such as, Women’s; Veterans; Civil Rights and Education conferences . Also we have what is known as a “Family Scholarship Conference” which usually runs in July, where you can take your family up there. Once you fill out an application, if selected, your stay, which will be from a Sunday to the following Friday morning, will be paid for by the region (We are Region 4) where the only thing you would have to do on your end is send a fifty dollar advance payment, which you will get back the day before you leave, and travel there yourself with your family, roughly seven hours from this area. 
These vehicles are made in the United States or Canada by members of the UAW and Canada's Unifor union, formerly the Canadian Auto Workers (CAW). Because of the integration of vehicle production in both countries, all of the vehicles listed as made in Canada include significant UAW-made content and support the jobs of UAW members.

However, vehicles marked with a single asterisk (*) are also produced in Mexico.

All heavy-duty Chevrolet Silverados and GMC Sierras will be built in Flint, Michigan, only. Light-duty Chevrolet Silverado and GMC Sierra regular cabs are produced in Mexico only. Vehicles marked with a double asterisk (**) are the crew cab versions of the Chevrolet Silverado light-duty and GMC Sierra light-duty trucks. Those are assembled by UAW members in Fort Wayne, Indiana, and also in Mexico.

When purchasing a vehicle marked with a single or double asterisk, it's important to check the Vehicle Identification Number (VIN). A VIN beginning with "1" or "4" or "5" identifies a U.S.-made vehicle; a "2" identifies a Canadian-made vehicle; a "3" identifies a vehicle made in Mexico. Not all vehicles made in the United States or Canada are built by union-represented workers. Vehicles not listed here, even if produced in the United States or Canada, are not union made.

DENTAL– If you returned to work in November and worked through December 3, 2021 your dental coverage Will be reinstated as of December 1, 2021. Delta Dental’s system will not be updated until December 9th or 10th To reflect that your dental coverage was reinstated as of December 1, 2021. If you do not return to work after December 6, 2021 you will have dental coverage until January 31, 2022.

SUB– The majority of members will be submitting a request for full SUB benefits for the week ending December 11, 2021 due to the fact that they have exhausted their unemployment benefits. If you have Exhausted your unemployment benefits you should have received a “Benefit payment Explanation” sheet. On That sheet under the box that shows the “Weeks Paid” it should state “You have exhausted your Unemployment Benefits” you will need to scan and upload this sheet and follow the step by step instructions Listed in the “2021 Manual instruction for SUB” that will be poste on the UAW 1268 website


(www.uaw1268.org). You only need to scan and upload Benefit Payment Explanation sheet once but you will have to attach it to every SUB request. The instructions will tell how to attach the document. **THE EARLIEST DATE YOU WILL BE ABLE TO SUBMIT A SUB REQUEST WILL BE MONDAY, DECEMBER 13, 2021. IF YOU SUBMIT A REQUEST BEFORE THIS DATE IT WILL BE DENIED AND WILL FURTHER DELAY YOUR SUB PAYMENT! THE EARLIEST DATE YOU CAN EXPECT TO RECEIVE PAYMENT IS FRIDAY, DECEMBER 24, 2021. YOU NEED TO ALLOW 2 WEEKS FOR SUB TO PAY OUT. SUB DOES NOT PAY OUT THE SAME WEEK YOU SUBMIT THE REQUEST. IF YOU DO NOT RECEIVE PAYMENT BY DECEMBER 31, 2021 YOU WOULD NEED TO CONTACT THE BENEFITS OFFICE ON MONDAY JANUARY 4, 2022. If you have not exhausted your unemployment benefits you will need to open a Claim (refer to instructions provided by Mike Moe)**




